

## *An In-Depth Examination of Lifestyle, Genetic Factors, and Biological Mechanisms in the Pathogenesis and Treatment of Acne*

The most widespread skin disorder, acne, predominantly affects teenagers and young adults; it affects about 80% of adolescents, varied in severity. Even if the physical symptoms of acne are often not severe, even if they are not immediately apparent from a medical standpoint, they can have a substantial influence on self-esteem and mental health. Fortunately, these psychological issues related to acne are becoming more widely understood.

Since most acne sufferers have siblings and parents who have previously had the ailment, family history is a significant factor in acne. There is a significant genetic component in its development, according to extensive study. According to twin studies, genetics may be between 50% and 90% of the cause of acne, while the ACE model claims that genetic variation accounts for 81% of the variance in the condition. Environmental factors, which contribute less than 20% to the expression of the illness, include birth weight, body mass index, height, and current weight.

Androgen excess, metabolic syndrome, and polycystic ovarian syndrome impact acne severity. Recent research in European populations highlights genes like SNP rs4133274 on chromosome 8q24, offering hope for better treatments. Ongoing studies assess acne medication safety, dietary factors, scar treatments, and lifestyle influences. Genomic research aims to uncover genetic links to acne, shedding light on prevention and treatment, while investigating sebum production and inflammation from *Propionibacterium acnes* remains a priority in understanding acne's causes.

You can safeguard your heart health with proactive checkups, including Hs-Troponin I and NTproBNP tests. HsTrop I, once a diagnostic marker, now predicts future cardiac events. Higher levels indicate increased heart attack and stroke risk. NT-Pro BNP is crucial for assessing cardiovascular risk in people with diabetes, who face double the risk. Regular checkups, regardless of age or gender, are recommended, especially for those with a family history of heart disease or sedentary lifestyles.

### **Heart Attack: Risk Factors You Should Know**

It is said that never judge a book by its cover; the same goes here. No matter how young or fit you look, the risk of heart attack in youngsters and older people is the same in the present scenario. The contributing factors to heart attacks in younger individuals include:

1. Unhealthy lifestyles
2. High blood pressure, aka hypertension
3. Overweight or obesity
4. Smoking
5. Substance abuse
6. Excessive alcohol consumption, and
7. A lack of physical activity

## ***CDSCO Alert by Indian Pharmacopoeia Commission***

***Voluntary Recall of Digene Gel manufactured by M/s Abbott India Limited, L-18 /19, verna Industrial Estate, Salcette, Goa-403722***

It was reported on 9th August 2023, that one bottle of Digene Gel Mint flavor batch no. 510303D7 used by Customer is of regular taste (sweet) and light pink colour whereas another bottle of same batch observed it was of white colour with bitter taste and pungent odour as per complaint. Accordingly, M/s Abbott India Limited, L-18/19, verna Industrial Estate, Salcette, Goa-403722 vide letter no. AB/RA/EPD/078- 2023 dated 11-08-2023, informed to this office for voluntary recall of impugned product Digene Mint flavor batch no. 510303D7 and Digene Gel orange having batch no. 500351D7, 500352D7, 500353D7, 500354D7 and voluntary stopped production of all variants of Digene Gel manufactured at their Goa facility: Further, M/s Abbott India Limited, L-18 /19, verna Industrial Estate, Salcette, Goa-403722 vide letter no. AB/RA/EPD/081-2023 dated 18-08-2023 intimated to this office regarding voluntary product recall of all batches of Digene Gel of all flavors (Mint, Orange, Mix fruits flavor) which are within the self life and manufactured at Goa facility. The impugned product may be unsafe and its use may result in adverse reaction.

# WHY POPULAR ANTACID HAS BEEN RECALLED



Based on the above, the following advisory is provided :

- To doctors and Healthcare Professionals: The doctors and healthcare professionals should carefully prescribe and educate their patients to discontinue the use and for reporting of any ADRs arising due to consumption of the said product. Healthcare professionals should promptly report any suspicious cases of adverse events linked to this product.
- To consumers and patients: To discontinue the use of Digene Gel which are manufactured at Goa Facility.
- Wholesaler and Distributors: The said impacted product with all batch numbers manufactured at Goa facility with in active shelf life to be removed from the distribution
- To Regulatory Authorities (All States/UTS Drugs Controllers and all Zonal and Sub-Zonal Offices of CDSCO): Instruct your officers to keep strict vigil on the movement, sale, distribution, stock of the said drug products in the market, draw samples if said product lying in market and initiate necessary action as per the provisions of the Drugs and Cosmetics Act and Rules made thereunder


