



IIMT College of Law organised a workshop on “**IPR AND IP MANAGEMENT FOR START-UP**” under the guidance of Prof. (Dr.) Monika Rastogi (Director), with Mr. Satish Kr Gupta, working as the event's coordinator. The session started with an extended cordial welcome of the guest speaker by Dr. Tanushree. At precisely 09:30 A.M., the session got underway. For the students, the workshop was highly instructive and helpful. Intellectual Property (IP), according to the speaker, is an intangible asset. He goes on to explain that after you become an advocate, you can also work in intellectual property. In the current environment, there is a substantial increase in the need for IP advocates. Advocates have opportunities due to various IP challenges. Further, the speaker elaborated that the term “intellectual property rights” (IPR) refers to the legal privileges accorded to the producer or inventor to safeguard their creation or manufactured goods. He explains that Intellectual property is protected in a variety of ways, including the Trademark Act of 1999, the Design Act of 1911, the Copyright Act of 1957, and the Patent Act of 1970. Trademarks are important corporate assets, and while registration is not required by law, it is advised given the lack of protection afforded to unregistered trademarks. If a different company seeks to use the same or a similar mark after registration, a relevant legal process will be available to prevent it.

Posters efficiently communicate concepts and data to an audience using a combination of visuals and text. Students wrote catchy titles containing relevant keywords to help the audience quickly recognize whether they’re interested in their poster. Poster presentations often are the first opportunities for young investigators to present their work at important scientific meetings. They kept methods to a brief overview instead of including detailed protocols. Generally, 5 figures or less were chosen only the most interesting data that are critical to support their conclusion. Poster presentation should be visual as possible; not only does it make your poster more appealing, but information can be transmitted more efficiently with a picture, figure, or graph. They used diagrams to illustrate complex concepts and were concise and only included the essential details required to grasp the whole story. The content was presented in 5 - 10 minutes by the student. Posters range in size, and you can usually present your poster either arranged portrait or landscape. Students were given ample time to describe their poster. It was a highly motivating session full of creativity. Students presented poster on various themes relating to innovation and business creatively.

According to the speaker,

- Copyright is a form of intellectual property law, protecting original works of authorship including literary, dramatic, musical, and artistic works, such as poetry, novels, movies, songs, computer software, and architecture.
- A patent protects new inventions, processes, or scientific creations, a trademark protects brands, logos, and slogans, and copyright protects original works of authorship.
- A trademark can be any word, phrase, symbol, design, or a combination of these things that identifies your goods or services.





The very first law which was discussed was arrest procedures mentioned in CrPC related to women, that women will be arrested by only a women constable, after sunset and before sunrise women cannot be arrested and if the arrest is necessary then permission from a magistrate is needed. Further, she discussed how in the workplace a woman has the right to report sexual harassment.

Several rights of women were also discussed:

- (i) Right to Free Aid
- (ii) Right to Privacy
- (iii) Right to Untimely Registration
- (iv) Right to Virtual Complaints
- (v) Right to Zero FIR
- (vi) Right to No Arrest
- (vii) Right to not being called to the Police Station
- (viii) Right to Confidentiality
- (ix) Right towards Crime and not a Medical Condition
- (x) Right to No Sexual Harassment


## NSS CLUB ACTIVITY ON SWACHH BHARAT ABHIYANAY


### SOCIAL CLUB ACTIVITY ON FEED ANIMALS SAVE ANIMALS



IIMT College of Law organised Social Club Activity named “FEED ANIMALS SAVE ANIMALS” on 3<sup>rd</sup> May, 2023 from 10:30 AM onwards. In this activity, students of the Law department participated. The students were inquisitive about the visit to the cow shelter/shed commonly known as Gaushala. Most of the students were familiar with the concept of gaushalas but have not observed the cattle rearing and their preservation from close. By organising such kinds of events, we encourage students to become close to other human beings, animals, and nature. Since the event was organised by the law department, the behind this activity was the Directive Principles of State Policy mentioned in the Constitution. Article 48 of the Indian Constitution emphasises the preservation and improving breeds and prohibiting the slaughter of cows and calves and other milch and draught cattle. Further, it was occasionally highlighted by our Honourable Prime Minister to serve cows and cattle roaming on the roads, by establishing Gaushalas. The current need shows that Gaushalas offer a superior alternative to managing these underprivileged animals. Although Gaushala serves many different purposes, its main objective is to improve the health of sick, diseased, and abandoned cattle as well as to give stray cattle a place to stay. Some Gaushalas are working to improve the local breeds, using them to supply the villagers with the best female calves as well as plenty of pure local milk and other products made primarily from cow dung and cow urine.

### NAAC ACTIVITY ON FINANCIAL LITERACY





### MINOR ACTIVITY ON YOUTH PARLIAMENT




IIMT College of Law organised a Minor Activity named “Debate Competition” on 8<sup>th</sup> May 2023 from 03:10 PM onwards. Under this activity, students of the Law department participated. The topic of the debate was “Does Data Collection by Authorities and Organisations a Privacy Intrusion? The students were supposed to speak for and against the topic. Amongst the 10 contestants, few spoke in favour of the topic, and few spoke against the topic. The first speaker named Jyoti while favouring the topic contented that Data protection is one of the most important parts of the right to privacy as a data protection law will protect your personal information, which is collected, processed, and stored by automated means or intended to be part of a filing system.

Unlike the European Union, India does not have any separate law which is designed exclusively for data protection. However, the courts on several occasions have interpreted data protection within the ambit of Right to Privacy as implicit in Articles 19 and 21 of the Constitution of India.

Further another student named Shashank stated that both the government and service providers collect personal data. This adds to the danger of data leakage. Privacy is protection from possible abuses of personal information or searches by the state, while Data Protection is the tool the law uses to make sure that an individual is protected from abuse of his personal information by another individual. Along with him, student named Vatsal stated Article 21 protects the right to privacy and promotes the dignity of the individual.



The interaction majorly focused on FIR, how cognizable and non-cognizable offences are distinguished, case diary, general diary etc. The assigned officer of the police station explained to students about the registration of FIR and how to respond to online FIR. Authorities further enumerated the number of criminal activities that the students were expected to be aware of and gave them a basic understanding of the role played by the police in maintaining law and order in our daily lives. The students were also tutored on how to file a complaint and the subsequent steps to be followed until the case ended. Other interesting topics covered were filing FIR (First Information Report), the role of law enforcement officers regarding cybercrimes, and recent arrests in the neighbourhood.

The entire session was very interactive and included very informative discussions on the hierarchy in the Police department, jurisdiction, rights and protection given to women, the juvenile justice system, the relationship between advocates and police officers.


## NAAC ACTIVITY
