Our team leader Subrat Garg led the team with much enthusiasm and motivated all the other team members. There were total 5 teams in the competition and Noida International University won the first prize.

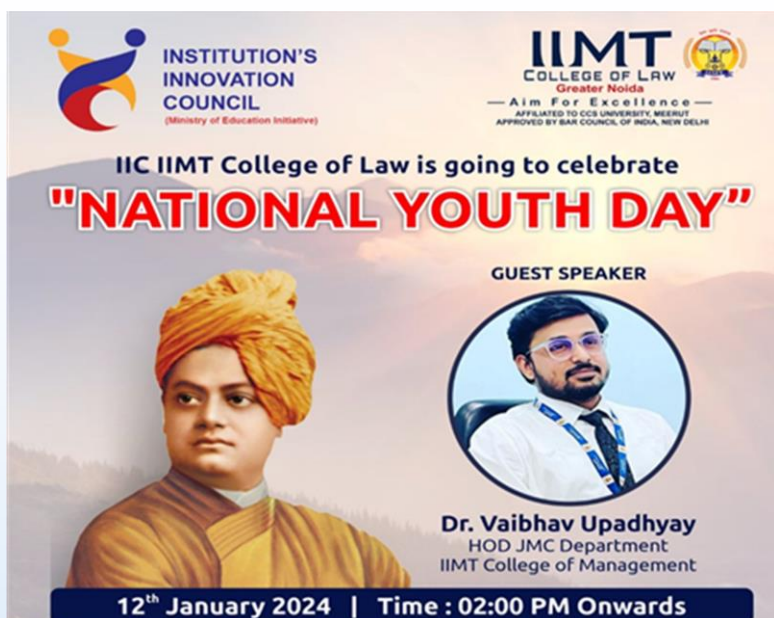
The Inter-College Tug of War Competition served as a platform for students to showcase their athletic abilities, build friendships, and foster a love for healthy competition.

## NATIONAL START UP DAY



The event commenced with an introduction highlighting the importance of entrepreneurship education in today's rapidly changing world and its relevance to students' personal and professional growth.

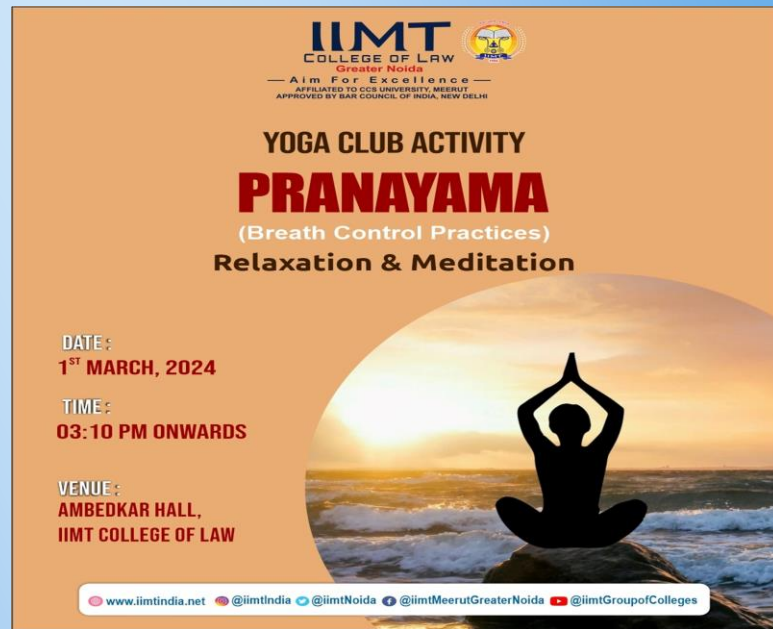

The purpose of the visit was to acquaint the students with the practical aspects of the legal system, particularly focusing on Alternative Dispute Resolution (ADR) mechanisms. The visit primarily revolved around observing the proceedings of the Lok Adalat, a vital component of ADR. Students keenly observed the proceedings, gaining firsthand insights into the functioning of the Lok Adalat and comprehending its significance in resolving disputes outside the traditional court system. The experience underscored the importance of arbitration and mediation in expediting justice delivery and reducing the burden on the conventional judicial system.

In addition to the legal proceedings, the visit also featured an exhibition showcasing the handcraft work of prison inmates. These stalls provided a platform for the inmates to exhibit their artistic talents and skills, offering a glimpse into their rehabilitation journey. 

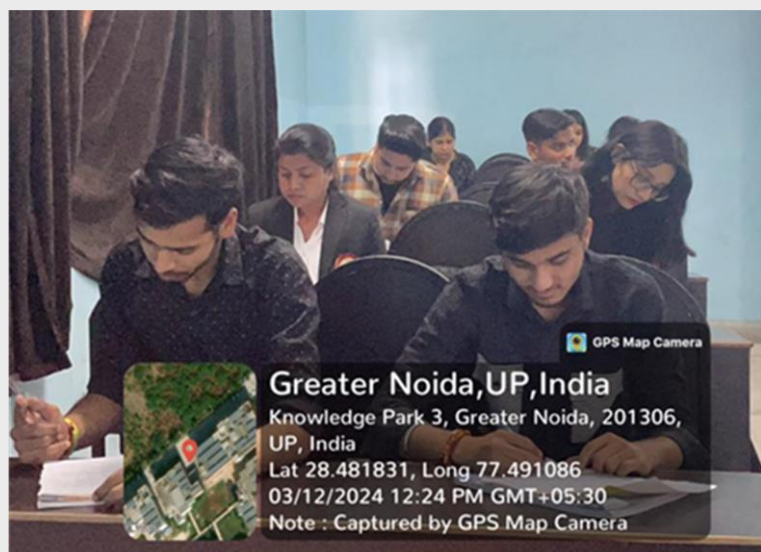
