





# Parliamentary Debate On “Capital Punishment”



IIMT College of LAW organized a Parliamentary debate on the topic of “Capital Punishment” on 29/04/2024. Ms. Kalpna Bharti, Assistant Professor, IIMT College of Law was the Coordinator for this event.



The debate was focused on the relevance of capital punishment in criminal justice system.

Debate teaches students the value of using convincing facts and well-reasoned arguments in real-world situations. Their use of rhetorical eloquence allows them to clarify their position. It provides debaters with a great deal of composure and confidence. It brings like-minded youngsters on the

same platform and offers a chance for the creation of a community to discuss and come up with the possible solutions.



Participants in favor of Capital punishment argued based on its deterrence effects on the criminal minds and the rights of victims to get justice by a court of law. On the other hand, participants who were against the capital punishment presented their arguments on the basis of some scientific studies and law commission report that deny its deterrence effect on society.



Debate on such topic provides an opportunity for students to develop critical thinking, by listening and countering arguments of opposite sides. Real-life examples and case studies were used by the participants during the debate and they demonstrated their oratory skills and their ability to think creatively on the spot.

# Workshop on IPR And IP Management for Start-Up



IIC-IIMT College of Law organized a workshop on **"IPR AND IP MANAGEMENT FOR**

**START-UP"** under the guidance of Prof. (Dr.) T.N. PRASAD(Director), with Ms. Bhavya Shrivastav, working as the event's coordinator.

Intellectual Property (IP), according to the speaker, is an intangible asset.

The speaker elaborated that the term "Intellectual Property Rights" (IPR) refers to the legal privileges accorded to the producer or inventor to safeguard their creation or manufactured goods. The legal rights, in other words, forbid anybody else from using the intellectual property for commercial gain without the owner's prior approval. Trade secrets, utility models, patents, trademarks, geographical indications, industrial designs, layout designs for integrated circuits, copyright and related rights, and new plant varieties are all examples of intellectual property (IP) rights.

She explains that Intellectual property is protected in a variety of ways, including the Trademark Act of 1999, the Design Act of 1911, the Copyright Act of 1957, and the Patent Act of 1970. Further, the speaker elaborated on the Design Act 1911."Design" is limited to the features of shape, configuration, patterns, or ornament applied to any article by any industrial process or means, whether manual, mechanical, chemical, separate, or combined, which

in the finished article appeal to and are judged solely by the eye. The Copyright Act, of 1957 protects original literary, dramatic, musical and artistic works and cinematograph films and sound recordings from unauthorized uses. There is no copyright protection for ideas, procedures, methods of operation or mathematical concepts as such. Finally, the Patent Act of 1970, is an exclusive right granted for an invention, which is a product or a process that provides, in general, a new way of doing something, or offers a new technical solution to a problem. Trademarks are important corporate assets, and while registration is not required by law, it is advised given the lack of protection afforded to unregistered trademarks. If a different company seeks to use the same or a similar mark after registration, a relevant legal process will be available to prevent it.


