Awareness programme: Swachhta Hi Sewa





## Guest Lecture on Digital India







#### Guest Lecture on Alternative Dispute Resolution



The Department of Law organized a guest lecture on "Alternate Dispute Resolution" on 23<sup>rd</sup> Oct, 2024 at 11:10 AM onwards. The guest lecture and session were delivered by Mr. Abhinav Singh (Advocate Supreme Court, Senior Panelist Central Govt.).

This activity was organized by Dr. Kaushiki Roy. Alternative dispute resolution (ADR) is a means of settling a dispute, conflict, or claim without courtroom litigation. Instead, the parties involved agree to use an ADR process such as mediation or arbitration. Alternative dispute resolution has gained broad acceptance by the public and the legal profession. If both parties involved in a civil (non-criminal) dispute willingly sign a contract to do so, they are free to choose ADR to resolve the matter.



When a lawsuit is pending, in some cases, courts encourage or require the litigants to use ADR to help settle disputes more amicably and reduce the court system's heavy caseload.






## Intra College Moot Court Competition




# Constitution Day Celebration


## Legal Aid Camp






# Celebration of National Energy Conservation Day




Guest Lecture on "Basics of IPR And Its Importance for Innovators and Entrepreneurs."
