

## Guest Lecture On “New Criminal Laws”



The event aimed to inform students about major changes brought by the government in Criminal laws in India and to explore new opportunity in criminal law practice in India.

The objective of the event was to provide students with insights into the changes in key principles and practices in New Criminal Laws in India and also to inspire students by showcasing successful new criminal lawyers practicing in India who can share their personal stories, challenges, and strategies for success, motivating them to pursue their career as criminal lawyer.




