




OUR FACULTY COMMUNITY


Certificates were presented to the faculty members for their active participation in one day national and international programmes i.e. seminar and workshop.






SESSION ON BUSINESS MODEL CANVAS



The expert lecture provided the young entrepreneurs a clear understanding of the legal and ethical steps required to start a business. This is an excellent opportunity to learn from the best and lay a solid foundation for building a successful business. Starting an ethical business usually includes a statement of your core values in your business plan. As you organize and shape your business, establish a code of conduct that includes standards of professional behaviour in your business. By developing policies and procedures for training your employees, you ensure that employees are held personally accountable for their actions. A business plan typically includes an executive summary, market analysis, business structure, product description, marketing strategy and financial statements. Establish roles and responsibilities for solving problems. Identify problems and motivate employees.

SESSION ON INNOVATION ECOSYSTEM DEVELOPMENT

The speaker narrated in detail how to identify a problem and gather relevant information and communicate this research effectively. According to him, Innovation ecosystems can operate at multiple levels (e.g. city, regional, national) and within multiple sectors (e.g. agriculture, health, education). Because of this breadth, it can be difficult to draw meaningful boundaries around who is or isn't part of an innovation ecosystem. It is therefore helpful to focus first on the sector and problem that the innovation is seeking to address (e.g. “low attendance rates among girls at government-run primary schools in Nairobi”) and then consider the specific actors, resources and contextual factors that the innovation will need to engage, utilise or influence to be impactful.



The competition was designed with the objective of strengthening the legal research and writing skills of aspiring lawyers, while also encouraging them to express their ideas and interpretations on significant legal issues through structured arguments and well-drafted submissions.

EDUCATIONAL VISIT TO AMRIT UDYAN

As a part of our educational activities, an educational visit was organized to Amrit Udyan, the famous garden complex of the Rashtrapati Bhavan, New Delhi. The programme was designed to provide students with an opportunity to explore India's rich cultural, historical, and environmental heritage outside the classroom setting. The visit aimed not only to supplement theoretical learning but also to offer practical exposure to the values of heritage conservation, biodiversity, and aesthetic appreciation.

During the visit, students were guided through the different sections of Amrit Udyan, including the Mughal Garden, Herbal Garden, Bonsai Garden, and Circular Garden, each representing a unique style of landscaping and horticulture. The blooming seasonal flowers, water fountains, and artistic layout of the gardens created an atmosphere of beauty and learning. Special attention was given to the flora diversity, as students observed both indigenous and exotic plant species, gaining insight into environmental sustainability and gardening techniques.



CASE STUDY COMPETITION

The Case Study Competition on "Stray Dogs and Public Policy: Unpacking the Supreme Court's Recent Judgement" was organized as an academic and policy-oriented initiative aimed at engaging students, and young professionals in critical analysis and policy formulation. The competition invited participants to explore and interpret the recent Supreme Court judgment concerning stray dogs, which has sparked national debate regarding animal rights, public safety, and governmental responsibility.

Participants were tasked with developing comprehensive case studies that unpack the legal, ethical, and policy implications of the verdict. This included examining the balance between animal welfare and public health, the role of local governments in managing stray dog populations, and the practical challenges of implementing humane control measures such as sterilization, vaccination, and adoption drives.



INNOVATION CLUB ACTIVITY

The IIMT College of Law had organised a valuable guest lecture on the topic of “TRANSFORMING TRADITIONAL LEGAL PRACTICES THROUGH INNOVATION”. Our esteemed guest speaker has a wide knowledge in the field of law and academics. The speaker motivated students to bring out their innovative and creative ideas and shared his experiences and steps of taking up the idea and making into reality. From her point of view, the path of innovation has three steps: Idea identification, innovative solution and finally setting up the start-up. She elaborated how innovation also helps the profession remain relevant by addressing evolving client expectations, automating mundane tasks to free up lawyers for strategic work, and fostering a modern, collaborative work environment to counteract the traditional perception of the legal industry as slow to change. She gave example of how AI and LegalTech tools offer opportunities to streamline operations, automate routine tasks, and improve the quality and speed of legal work.
