



# NGO VISIT & LEGAL AID CAMP

The Social Club of IIMT College of Law

organized an NGO visit to Ramlal Vriddhashram Evam Gaushala as part of its community outreach initiative. The visit was held on 3 October 2025 at 2:00 PM onwards for first-year students (B.A. LL.B., B.Com. LL.B., and LL.B.). The program aimed to sensitize students to social responsibility, compassion, and service by providing firsthand exposure to the functioning of an old-age home and gaushala. In addition, the visit emphasized the importance of legal aid and access to justice, where students were made aware of the legal issues commonly faced by senior citizens and marginalized sections of society. Discussions highlighted the role of legal awareness, free legal services, and student involvement in promoting legal literacy and support for those in need. The visit took place at Ramlal Vriddhashram Evam Gaushala, Greater Noida, offering students a meaningful opportunity to connect legal education with community service beyond the classroom.



# NATIONAL MOOT COURT COMPETITION

The 2nd National Level Moot Court Competition 2025 was successfully organized at IIMT College of Law, Greater Noida, on 14-15 October 2025. The event was conceived with the aim of providing law students from across India a platform to develop and demonstrate their advocacy and research skills in a simulated court environment. Upholding its commitment to excellence in legal education, IIMT College of Law ensured a highly competitive and enriching experience for the participants through a realistic moot court problem set on contemporary legal issues involving dowry death, evidence law, and criminal jurisprudence. The competition witnessed an overwhelming response, receiving a total of 61 registrations from law colleges and universities nationwide. Out of these, 52 teams reported and competed in the multi-stage event, which included researcher tests, preliminary rounds, quarterfinals, semi-finals, and a grand finale. Each team comprised three members—two speakers and one researcher—ensuring a balanced representation of advocacy and research skills in every round. The event's structure promoted rigorous argumentation on both sides of the given proposition and provided students with the opportunity to argue as both petitioner and respondent. The final round of the competition was judged by esteemed acting Judges of various High Courts, lending unparalleled prestige and expert evaluation to the event. Winner: Team Code IIMT25/040 (University Institute of Legal Studies, Punjab University Chandigarh), awarded ₹15,000.

- **Runner Up:** Team Code IIMT25/056 (Symbiosis Law School, Pune), awarded ₹10,000.
- **Best Mooter:** Aashita Sabikhi (Team 010 Mooter 1 of Maharaja Sayajirao University, Baroda), ₹3,100. Best Researcher: Palak (Team 041 Punjab University, Ludhiana), ₹3,100.
- **Best Memorial:** Team 040 (Tanvi Gupta, Mitali, Jashanpreet from University Institute of Legal Studies, Punjab University Chandigarh), ₹3,100.




# SUPREME COURT VISIT

The Law Student Delegation conducted an intensive educational visit to the nation's highest judicial body, the Supreme Court on 16th October 2025. The program was designed to offer students a crucial, firsthand view of the apex court's operations, bridging the gap between theoretical legal studies and judicial practice. The core of the visit was the observation of live proceedings (e.g., oral arguments/a public session) in the courtroom, allowing students to witness the judicial conduct of the Justices, the decorum of the court, and the advocacy skills of senior counsel. Following the observation, the delegation received a briefing from a court official (e.g., a Registrar/Law Clerk) on the procedural aspects of filing, case selection, and the internal working of the court. The day concluded with a guided tour of the Supreme Court Museum/Library, highlighting its history and significance in the country's constitutional framework. The event successfully offered a practical, immersive experience into the machinery of justice at the highest level.



# ROAD SAFETY & TRAFFIC RULES

On the occasion of National Legal Services Day, the IIMT College of Law organized a “Road Safety and Traffic Rules Student Awareness Workshop” to promote awareness about traffic regulations and responsible road behavior among students. The programme aimed to educate participants about the importance of road safety, legal provisions related to traffic violations, and the role of citizens in preventing road accidents. The workshop commenced with a welcome address by the faculty members, followed by an insightful session conducted by officers from the Traffic Police Department, who shared their practical experiences and valuable guidance on safe driving practices. They explained various traffic rules, the significance of wearing helmets and seat belts, avoiding mobile phone usage while driving, and adhering to speed limits. The session also highlighted the legal aspects of road safety, emphasizing the provisions of the Motor Vehicles Act and the legal consequences of violations. Interactive discussions and questionanswer rounds made the workshop highly engaging and informative for the students. The event successfully enhanced students’ understanding of the connection between law and social responsibility, inspiring them to act as responsible citizens and spread awareness about road safety within their communities.


# GOVERNMENT OBSERVATION HOME VISIT
