

give the introduction of Judicial Services Examination, which also known as the Provincial Civil Service – Judicial. P.C.S.- (J) Examination is an entry-level exam for law- graduates seeking to join the subordinate courts. Members of the lower judiciary are appointed by state governments under the supervision of their respective high courts, based on a competitive examination. There are two types of judiciary examination in our country such as Lower Judiciary Services - To sit for the Judicial Services Examination, you must have a bachelor's degree in law and have enrolled or qualified to be

enrolled as an advocate under the Advocates' Act 1961. No prior experience is required, and final-year students are welcome to apply. The age varies state-wise. It is commonly between the ages of 21 and 35. Higher Judiciary Services– Candidates must be graduates in law and have a minimum number of years of litigating practice (usually seven years). Judicial Service Examination is held in three successive stages namely Preliminary Examination, Mains and Viva-Voce / Interview. Preliminary Examination– The preliminary examination serves as a screening for the mains exam. It comprises objective type questions. The marks secured in the preliminary examination are not counted for the final selection. The percentages of qualifying marks vary as per state. The minimum qualifying marks in the preliminary examination is 60 percent for general and 55 percent for reserved categories. Mains Examination– The mains examination is a subjective type. The exam comprises three to four papers. The marks secured by candidates are counted for the final selection. Candidates equal to three times the number of vacancies are called for viva-voce. Viva-Voce/Personal Interview– This is the final stage of selection where candidates are

assessed on general interest, personality and intelligence among other factors. Around 100 students have attended the session which is benefit in terms of to crack the judiciary.



IIMT College of Law organised Online Guest Lecture on **General View of IPR Laws** on 30<sup>th</sup> September, 2021 on Microsoft Team from **11.30 A.M. - 12.20 PM**. The speaker of the event was Ms. Aarohi Ojha (Assistant Professor, Jagran Lakecity University, Bhopal). The speaker explained that ideas, innovations, and creative expressions based on which the public is ready to confer the status of property have been classified as intellectual property rights (IPR). IPR give the inventors or developers of a property certain exclusive rights in order for them to profit commercially from their creative work or reputation. Intellectual property protection comes in many forms, including patents, copyright, trademarks, and so on. A patent is awarded to an invention that meets the requirements of worldwide novelty, non-obviousness, and industrial applicability. IPR is required for better invention or creativity identification, planning, marketing, rendering, and therefore protection. Depending

on its field of expertise, each industry should have its own IPR rules, management style, strategies, and so on.

## LEGAL VISITS

The term prison is derived from the Latin term which means to seize. According to Oxford English Dictionary prison means a place properly efficient and equipped for the reception of

persons who by legal process are committed to it for safe custody while pending of trial and punishment.. Under the Government of India Prisons Act, 1870 prison means any goal or penitentiary including the airing grounds and other grounds or buildings engaged for the use of the prison.



Prison means jail or any place which is used for the detention of prisoners permanently or temporarily under the general and special orders of a Local Government. According to the Encyclopaedia Britannica prison means an institution used for the confinement of persons who convicted for major crimes or felonies. Traditionally, prison means a place in which persons are kept in custody when trial is pending or in which they are confined as punishment after conviction. The meaning of

prison is different for different people like for law abiding person it is a place where criminals end up and for criminals it may be a vague peril or an unavoidable humiliation and for social inadequate it may be a shelter and for some isolated persons prison may be a place where they can find some appearance of championship and for prison officer prison is a place of work and for the psychologist it is a career in studying behaviour and for other persons it is an experience which slows up time, which crowns them together, sets them apart and changes the course of their lives.

Keeping in view of the above objectives IIMT College of Law, Greater Noida and D.L.S.A. has organised a legal visit to Gautam



Buddh Nagar District Jail on **30<sup>th</sup> July, 2021**. The visitors reached the premises of the jail at 12.00 PM and were asked to sit in the visitor room adjoining the

premises of the main entrance of the Jail. Through the cross-checking and stamping we entered into the premises of the jail.



The Superintendent of the Jail and Shri Vijay Kumar Verma (Add Chief Judicial Magistrate & Secretary of DLSA, Gautam Buddha Nagar) narrated the introduction of Section 167 of the Cr.P.C. when investigation is not completed within 24 hours and police ask for the remand of 14 days. The person should be sent to remand after completion of the remand period & the prisoner should be sent into the jail with S.167 warrant remand forwarded by the magistrate. They have also mentioned the S.209 of the Cr.P.C. where cases have been committal to the Session Courts after finding investigation. After

wards we have moved to the hospital where prisoners infected with TB has been shifted and the process of recurring is there .We have also witnessed the temporary jail where new prisoner will go for 14 days quarantine period, afterwards he/she will be shifted to the main premises of the jail. It was wonderful experience for us to understand the rights of the prisoners and the jail manual.

### LEGAL AID CAMP

A Legal Aid Camp was conducted by the students of IIMT College of Law, Greater Noida in collaboration with District Legal Services Authority, Greater Noida on **September 17<sup>th</sup>, 2021** in various locations of concerned Tehsil i.e. village Tugalpur, village Sakipur, Jagat Farm Market & Zeta-I.



Law student Madhurendra Kumar enlightened the masses on the topic of Basic Rights and briefed importance of Article-21; in the same reference another law student Lokesh Sharma threw light on various points of Right to Information Act-2005 and suggested how to correctly use RTI act for curbing corrupt system. Student Umang Gangwar informed people about main points of Maintenance and Welfare of Parents and Senior Citizens Act, 2007 Southampton they may utilize it. Student Govind Kumar Atul discussed on various aspects of Lok Adalat with the present gathering while student Vinayak Kumar spread awareness about the Rights to Equality as enshrined in the constitution. In the same sequence the people present in Camp showed interest in receiving information about Law and discussed a lot with law students.

*They have become as dry as hay.*


