"Believe yourself & you are almost there."

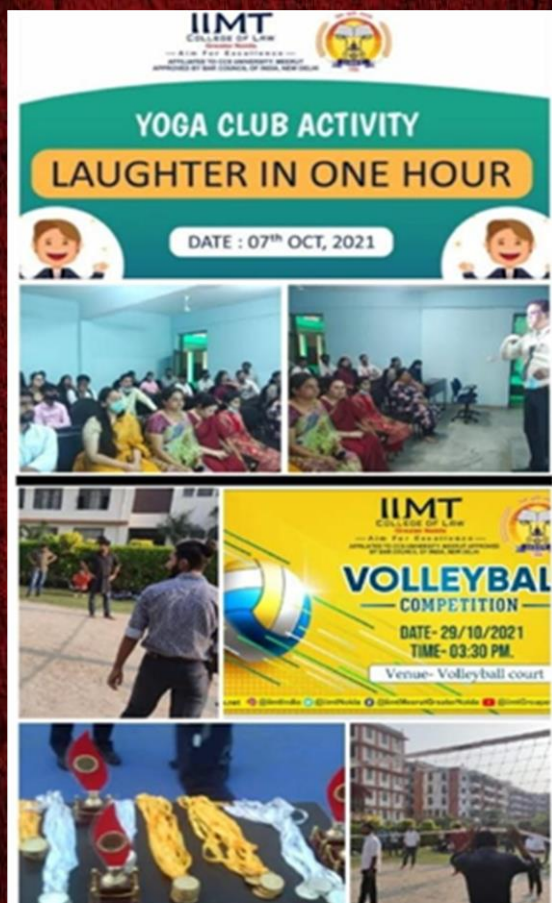
