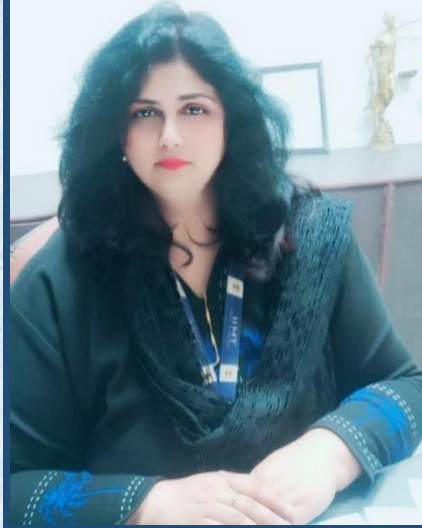



- **Poster Making Competition**



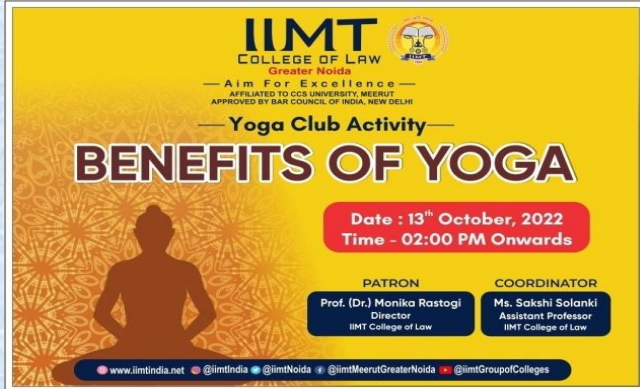

- *Fancy Dress Competition*

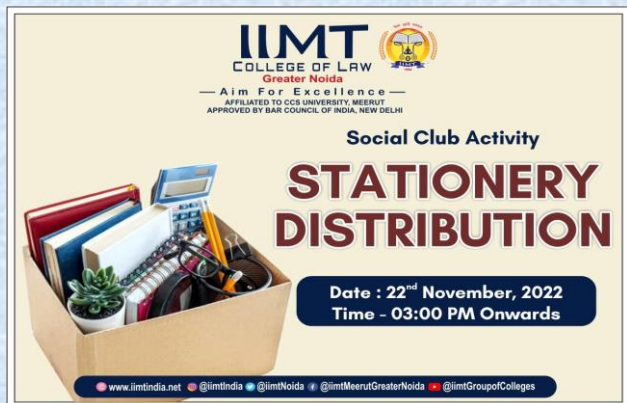

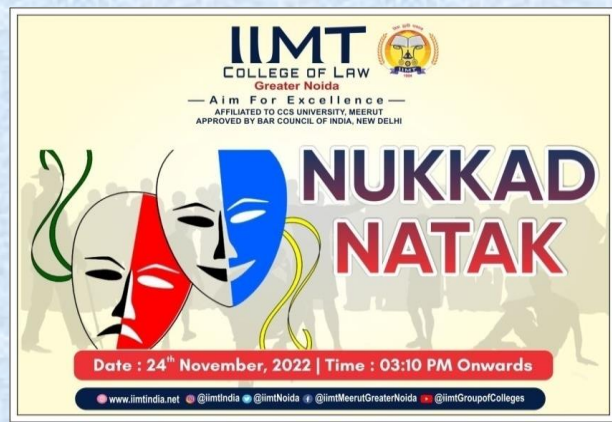
- **Stationary Distribution**
