## SUR SANGAM COMPETITION

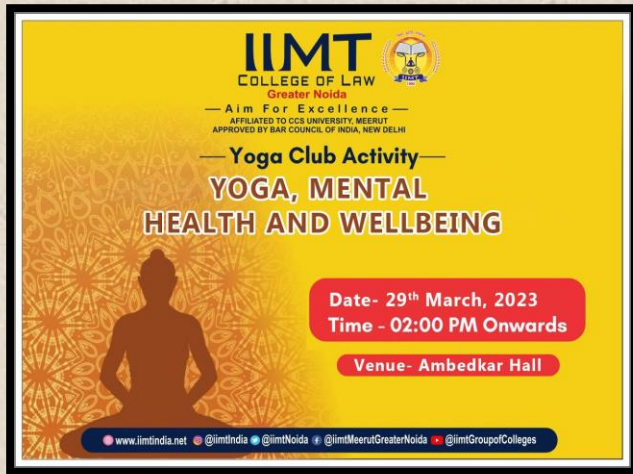

- **SAY NO TO PLASTIC NVIORNMENT**




