Mr. Satish Kr Gupta, working as the event's coordinator. The session started with an extended cordial welcome of the guest speaker by Ms. Saloni Tomer. At precisely 12:00 PM, the session got underway. For the students, the session was highly instructive and helpful. According to the speaker, Angel investors/VCs can provide businesses with much-needed growth capital. He goes on to explain the Advantages of Angel Investing. He explains the main advantages of receiving an investment from angel investment. He describes the startup ecosystem such as support organization, big companies, universities, research organizations, service providers, and funding organizations. He explains the meaning and definition of venture capital/capitalists, features of venture capital, as well as methods of venture capital financing. Apart from these he differentiates between Angel and VCs. Further, he explains the funding process that involves four phases such as Idea generation, Start-up, Ramp up, Exit. In recent years, angel investing has expanded to include large group of investors who each contribute a small in order to crowdfund a much larger investment. Apart from this he explains the various

Ms. Pragya Shukla was the coordinator of the event. The honourable guest started the session at 03:00 P.M. It was a highly interesting session. Our esteemed guest speaker has a wide knowledge in this topic. The speaker explained what is value proposition and explained that, it is a brief statement of the advantages that a company delivers to its customers who purchase its products or services is an effective value proposition for marketing. He also told that term "value proposition" first appeared in a 1988 McKinsey & Co. industry research paper, which defined it as "a clear, simple statement of the benefits, both tangible and intangible, that the company will provide, together with an approximate price to be charged to each customer for these benefits." The firm's value proposition informs the customer as to why a product or service is best suited for that particular client. The value proposition must be communicated to customers in a direct manner, either by means of the company's website or other promotional and advertising materials. The value proposition may, as long as it is "on the label," unique and specific for the company concerned, be subject to a variety of formats. As long as the values are "on brand", unique and specific to the company concerned, they may vary from one format to another. A successful proposition needs to be persuasive and can help a prospect become an active customer. He further discussed 3 levels of business fit which is needed in every business these are-Problem-Solution Fit, Product- Market Fit, Business Model Fit.

IIC-IIMT College of Law organised "SHORT VIDEO COMPETITION ON THE IMPLEMENTATION OF NEP KI SAMAJH". Dr. Munish Kumar Sharma was the coordinator of the event. In this competition students posted their short videos on Youtube regarding the various aspects of NEP as per the requirements of Ministry of Education. National Education Policy 2020 has been announced on July 29, 2020. The National Education Policy 2020 proposes various reforms in school education as well as higher education including technical education. A number of action points/activities for implementation in school education as well as higher education are mentioned in the National Education Policy 2020. The vision of the policy is to build an education system rooted in Indian traditions that contributes directly to transforming India by providing high-quality education to all in their mother tongue, thereby making India a global knowledge superpower. The policy is inclusive in nature and focusses on practical aspects of knowledge. NEP, 2020 aim to increase the GER to 100% in preschool to secondary level by 2030 whereas GER in Higher Education including vocational education from 26.3% (2018) to 50% by 2035. The single overarching umbrella body for the promotion of the higher education sector including teacher education and excluding medical and legal education- the Higher Education Commission of India (HECI)-with independent bodies for standard setting-the General Education Council; funding-Higher Education Grants Council (HEGC); accreditation- National Accreditation Council (NAC); and regulation- National Higher Education Regulatory Council (NHERC). The students were very enthusiastic about the activity.

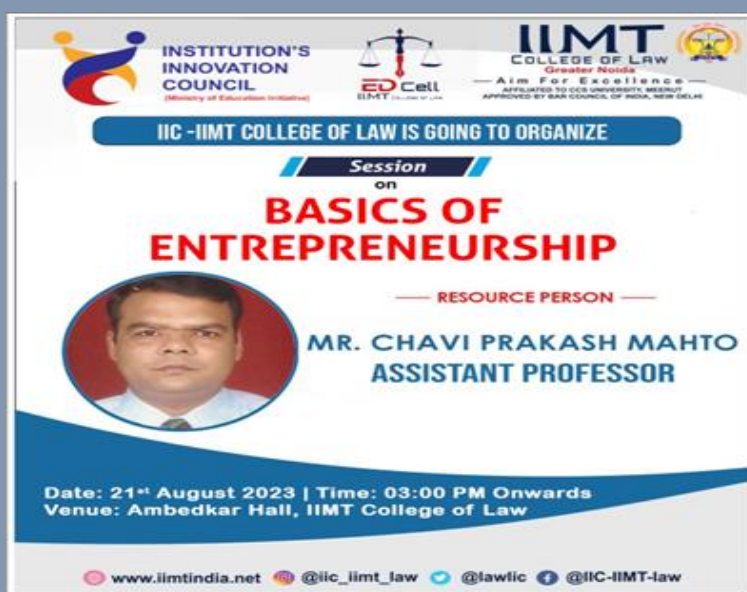

SESSION ON ALUMNI EVENT -1

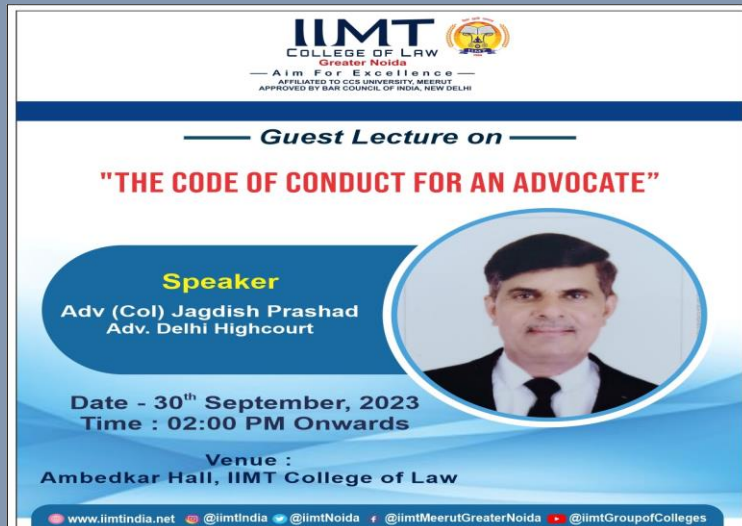

GUEST LECTURE ON THE CODE OF CONDUCT FOR AN ADVOCATE



IIMT College of Law conducted a guest lecture on "The Code of Conduct for an Advocate".

The resource person was Adv. (Col.) Jagdish Prasad, who is currently practising at Delhi High Court. The guest discussed 33 points about the code of conduct that are considered ethically important for lawyers. The lecture was very informative and thought-provoking as it described the difference between ethical and legal aspects of advocacy. The speaker said that an advocate is an officer of the court. So, he has to follow etiquette and abide by the law. An advocate should not try to influence the decision of the court. An advocate should not represent the case of the client, who uses unfair means or unethical approaches. It is also said that communications between the client and the Advocate are not to be revealed at any time. They are protected by attorney-client privilege. It is immoral for an advocate to hide any relevant facts or evidence. An essential component of the legal profession is the conduct of advocates. A code of ethics for advocates is established by the Advocates Act of 1961. It contains guidelines for how they should conduct themselves in court, with clients, and in public. A high standard of professionalism and moral conduct must be upheld at all times by advocates. Students took a keen interest in asking various questions to the keynote speaker. Students raised various questions regarding the actual process and etiquette during court proceedings which were aptly answered by the guest. Students and faculty came forward to enrich the session and lead it towards success.
