IIMT College of Polytechnic, Plot No. A-20, Knowledge Park III, Greater Noida, Gautam Buddha Nagar, Uttar Pradesh -201 306 should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.

As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.
